DURHAM'S ONLY POLICEWOMAN DIES SUDDENLY

Mrs. Katherine Williams Succumbs Before Doctor Reaches Bedside This Morning

Mrs. Katherine Margaret Williams, mother's aid director and girl referee for the Durham welfare department, died at her home on the Wake Forest road this morning at 7 o'clock following an illness of a few days. Death resulted from a complication of diseases. She was dead when medical aid reached the home.

Mrs. Williams was the wife of Marvin E. Williams and was 36 years of age. In addition to her husband she leaves a step-son, Rufus C. Williams of this city; four sisters, Mrs. A. F. Spain of Durham, Misses Dora and Nellie Norman of Raleigh, and Mrs. C. L. Smith of Plymouth; and two brothers, Roscoe and George Norman, both of Durham.

The funeral will be held Wednesday afternoon at 3:30 o'clock at the Edgemont Baptist church. The pastor, Rev. C. S. Norville, will officiate.

Mrs. Williams bore the distinction of being the only policewoman in the county. She had devoted practically her entire life to welfare work, becoming associated with the local department while she was attending high school. She took special training at the University of North Carolina. During the past eight years she has been a full-time member of the department. She was considered by welfare officials one of the best equipped and most efficient workers in the state.

Mrs. Williams, in addition to looking out for the mothers aid work in the county, devoted much time to girls who had become delinquent in their conduct. She was also an experienced case investigator. About a year ago she was commissioned as a police officer.
