Biographical / Historical

Located on Leon Street in Durham, NC, Brogden Middle School opened in 1959 as part of the Durham city schools system. It was named after Willis J. Brogden, a justice of the North Carolina State Supreme Court appointed in 1925. He was also involved in Durham affairs, serving as the city's mayor 1911-1915 as well as principal of Fuller School county attorney. The school was initially a junior high school serving grades 7-9. When the school opened two black students applied to attend, part of a strong protest among the black community of Durham schools' lingering segregation. However, desegregation did not begin in earnest until 1963. Brogden was changed from a junior high to a middle school serving grades 6-8 in 1982, along with other junior high schools in the system. The building was remodeled in 1976 and 2000.

Scope and Contents

The collection contains reports, brochures, clippings, photographs, and serial publications documenting the history of Brodgen Middle School. The reports are for periodic accreditation evaluation with the Southern Association of Colleges and Schools (SACS). Publications include newsletter "News from the Dragons' Den," student-run newspaper The Satellite, and compilations of student poems and writings. Photographs document school classroom scenes and outdoor activities, as well as larger portraits of the football team. The collection also contains a 16 mm reel film of promotional material.
