Abstract:	The Howard Clement Papers span the years 1945 to 2013. Clement was a civil rights activist, lawyer, executive at North Carolina Mutual Life Insurance Company, a state representative in the North Carolina General Assembly, and a Durham city councilman for 30 years. In addition to documenting Clement's professional and political career in Durham, the collection also documents his dedication to myriad local, regional, and national causes. Items in the collection include personal and professional correspondence, memoranda, meeting minutes, reports, print material, ephemera, photographs, and video and sound recordings. The collection is arranged in the following series: Chronological Files, Alphabetical Files, Correspondence, Affiliations, North Carolina Mutual, City of Durham, Photographs and Audiovisual, Miscellaneous, and Oversized Materials.

uocuments Ciement's professional career, civic leadership and engagement, and his three decades of service on the Durham City Council.

The Chronological Files Series ranges in date from 1960 to 1998 and 2004 to 2007. This series consists of materials collected and organized by Clement that document his personal and professional life. It contains correspondence, memoranda, reports, minutes, clippings, print material, and ephemera including receipts, event and travel tickets, greeting cards, and programs. The early materials document Clement's career with North Carolina Mutual and his early political activism. The North Carolina Mutual material includes memoranda, travel expense reports, newsletters, promotion acknowledgments, information about Jesse Jackson's visit to Durham in 1984, and about Clement's retirement in 1990. Some material relates to Clement's participation in the March on Washington for Jobs and Freedom, including a program and a letter to North Carolina Mutual expressing disappointment in the company's lack of presence at the march. A number of local, state, and national organizations and events are also represented in the material. Local organizations include Women-In-Action for the Prevention of Violence and its Causes, Durham Committee on the Affairs of Black People, Durham County Democratic Party, Hayti Development Corporation, Duke's Black Student Alliance, and the Conference on Urban Change held at Duke University in 1968. State organizations include the North Carolina Association of Black Lawyers, North Carolina Civil Liberties Union, North Carolina League of Municipalities, N.C. Black Caucus, and the State Political Rally of Black Educators (1972). An abundance of material documents Clement's party activism, including his participation on the Rules Committee of the Democratic National Convention in 1972, his public conversion to the Republican Party in 1988, and his participation in the Republican National Conventions in 1988 and 1992.

The Alphabetical Files Series ranges in date from 1945-2007 and consists of material relating to local events, membership rosters of local boards, committees, and nonprofit organizations; writings and speeches by others; and some material documenting Clement's legal career.

The Correspondence Files Series ranges in date from 1962 to 2012, with most created from 1987 through 2012. The series is divided into two subseries, 1) Personal and 2) Professional Correspondence. Most of the professional correspondence subseries focuses on his service on the City Council, to which he was appointed in 1983. It also includes material created while Clement was with N.C. Mutual. Among the topics covered in the City Council correspondence include the death penalty, pornography and sexual violence, crime and crime prevention, alcohol and substance abuse; zoning, housing, and transit matters; Durham city-county merger, various improvement plans and projects, and letters from concerned citizens. Topics included in the N.C. Mutual correspondence include routine business matters, Clement's promotion to director of Advertising and Public Relations in 1988, solicitation letters from local advertising agencies and publications regarding ad space, and N.C. Mutual sponsorship opportunities. Organizations represented include the national Democratic and Republican Parties, the North Carolina Bar Association and Association of Black Lawyers, the American Council of Life Insurance, the North Carolina League of Municipalities, North Carolina Institute of Minority Development, and numerous boards and committees

The Affiliations Files Series ranges in date from 1955 to 2008, with some undated material. It is divided into seven subseries: civic, corporate, educational, fraternal, political, professional, and religious. The affiliations files represent the range of boards, committees, commissions, task forces, etc., on which Clement has served in an official capacity. Types of materials in it include correspondence, memoranda, meeting minutes and agendas, by-laws and constitutions, printed material, and financial materials. The Civic Affiliations Subseries includes material relating to a number of local and national organizations including Downtown Durham Rotary Club, Greater Durham Chamber of Commerce, Eagle Village Development Corporation, and the Salvation Army. Types of materials in it include correspondence and memoranda, meeting agendas and minutes, financial materials, rosters, printed material, ephemera and, for some organizations, constitutions and by-laws. The Corporate Affliations Subseries, which covers 1986-1990, includes information on the American Corporate Council Association, Invictus, Inc., and Planters Bank, The Educational Affiliations Subseries, with a date range of 1982 through 2003, contains material relating to Clement's activities with local schools and universities, most prominently Hillside High School and North Carolina Central University. Hillside material documents his work on various committees including the Business Advisory Committee, the Model High School Task Force, and the Planning Committee. Also present is material relating to Clement's interest in broader issues facing public schools, such as school violence and disparities in achievement. Prominent among them are materials related to the Task Force for Closing the Achievement Gap and the School Violence Task Force, including correspondence and memoranda, meeting agendas and minutes, surveys and reports, clippings, and print material. The Fraternal Affiliations subseries materials include correspondence, print material, rosters, and some committee records that document Clement's association with the A. S. Hunter Lodge, Alpha Phi Alpha, and Alpha Tau Boule. The Political Affiliations Subseries material relates to Clement's activism in both the Democratic and Republican Parties from the early 1970s through 1998, plus his attendance at the inauguration of Barack Obama in 2009. documents his work with the Democratic Party and his communication with prominent Democrats including then-U.S. Senator Robert Morgan and Attorney General Lacy Thornburg. Materials relating to his role on the State Executive Committee of the party are also included. From 1987 forward, much of the material relates to various activities with the Republican Party, including items relating to local party organization before the 1988 presidential election, his selection as a delegate to the Republican National Convention, and his role with the N.C. Minority Republican Council and Presidential Personnel Advisory Committee. Included are correspondence, minutes, print material, and ephemera. The Professional Affiliations Subseries includes material relating to Clement's involvement with several local and state legal associations, including the North Carolina Association of Black Lawyers and the North Carolina Bar Association. Most of the material documents his involvement with the George H. White Bar Association, a Durham-based organization of African-American attorneys including the group's constitution and by-laws, correspondence, meeting minutes, membership rosters, and committee materials. The Religious Affiliations Subseries includes material related to Clement's role on the Board of Directors of the North Carolina Episcopal Foundation, an organization dedicated to aiding the expansion of the church in North Carolina. A substantial amount of material relates to his involvement with St. Titus' Episcopal Church, including correspondence, financial records, meeting minutes, and printed material.

The North Carolina Mutual Files Series ranges in date from 1945 to 2002, with some undated material. Included are general and departmental correspondence and memoranda, clippings, committee materials including Founder's Day Committee and "Whetstone" Editorial Committee (the "Whetstone" is N.C. Mutual's newsletter), personnel files, printed material, and material relating to various national insurance organizations including the Life Communicators Association and National Insurance Association. Also present are materials relating to the attempted unionization of N.C. Mutual staff by the Office and Professional Employees International Union (OPEIU).

The City of Durham Series ranges in date from 1971 to 2013. Making up most of the collection, the majority of materials in this series document Clement's three decades of service as a member of the Durham City Council. Materials, which are arranged alphabetically, primarily relate to several topics: City annexations, budget matters, and capital campaigns; City-County matters, including the proposed merger of City of Durham and Durham County services; committee work; fiscal and structural development projects; issues relating to housing in Durham; personnel matters; and reports and studies. Annexation materials include studies, analysis, and meeting minutes relating to the annexation of 751 South, Parkwood, and the South Miami Boulevard area. Budget materials include reports and studies, preliminary budgets, planning retreats, and presentations. City-County material includes reports and minutes of the Citizen and Merger Task Forces, the Joint City-County committee, and consolidation reports. Also present are materials relating to the activities of the Gang Assessment and Oversight Committee, including meeting minutes and reports. Materials documenting Clement's service on various committees include agendas, minutes, and reports of the Audit Services Committee, Citizens Advisory Committee, Taxicab Subcommittee, and the Truancy and Gang Preventions Committee, among others. A significant portion of the City of Durham material relates to local and, in some cases, regional development plans and projects. Major development projects include the ongoing development of the American Tobacco Campus and the Durham Bulls Athletic Park, downtown Durham, the Durham Performing Arts Center, and Rolling Hills/Southside revitalization. Materials include committee meeting minutes, reports, draft plans, zoning documents, correspondence, and architectural plans and renderings. Materials created in the service of the Durham Housing Authority comprise a majority of the housing-related material, including agendas and minutes of the Board of Commissioners and directors, budget and other financial materials, long-term planning papers, and grant projects. Material relating to state and federal housing law and specific housing projects is also included. Personnel materials include investigations of individual employees and some policy material. The majority of these files are restricted. Reports and studies, both internal and published, cover a range of topics. Subjects include transit, community assessment, economic development opportunities, feasibility studies, youth and crime, property and facilities management, and road and greenway development.

The Photographs and Audiovisual Series ranges from 1899 to 2013 and includes photographs of Clement's family, his work as a city councilman, including trips to Durham's sister cities in Russia, Tanzania, and Japan; his work at North Carolina Mutual Life Insurance Company, visits with state and federal politicians including George H. W. Bush and Jesse Helms, and his work as a lay minister at Titus Episcopal Church. The videos include several from the Durham Visitor's and Convention Bureau and city council meeting clips.

The Miscelleanous series includes publications that Clement collected personally, such as materials related to President Barack Obama's election, as well as publications relating to Durham. The series also includes newspaper clippings about Howard Clement and ephemera relating to him, including his membership cards for the Republican and Democratic Parties, campaign buttons for himself and presidential candidates such as Nixon and Carter, and a set of check registers that belonged to Clement covering 1965-2005.

The Oversized Series includes maps and architectural drawings that were pulled out of other series for size reasons and also includes a campaign poster for Clement when he ran for mayor of Durham, drawings sent by students to Clement has a thank you for visiting their class, and a panorama photograph of President Harry Truman speaking at Howard University's 1952 commencement.
