Abstract:	The permission pass illustrates the financial cost and special arrangement needed for an enslaved person to carry a firearm in 18th century North Carolina, and that London was classified as "property" by the lawyers issuing the permission.

# **Biographical / Historical**

James Iredell immigrated from England and worked as the deputy collector of Edenton, a port in North Carolina, starting in 1774. In 1778 he was elected a judge of North Carolina's superior court, and was attorney general from 1779 to 1781. In 1790 he became a Supreme Court associate justice after being nominated by George Washington.

Francis D. Winston was lieutenant governor of North Carolina from 1905 to 1909 and raised on "Windsor Castle" plantation in Bertie County. Winston was an attorney after graduating in 1879 from the University of North Carolina. He served in the North Carolina Senate in 1887, representing Bertie and Northhampton Counties. Elected to the North Carolina House of Representatives in 1898, he assisted in heading the "white supremacy" campaigns of the Democrats in 1898 and 1900.

## **Scope and Contents**

The collection consists of three items: an original handwritten permission pass signed February 12, 1783 by James Iredell and John Johnston, for London, an enslaved person, to carry a gun as overseer on a plantation in Bertie County; a pre-printed card from "Francis D. Winston, of Bertie" describing the item; a transcription of the document.

#### Arrangement

Folder contains both pieces of a handwritten document identified on separate pre-printed card as "Bond permitting a Negro Overseer to carry a gun. Signed 1783, by James Iredell, Justice Supreme Court, United States. Presented by Francis D. Winston, of Bertie", and transcription of the document.
