Durham County Library Foundation Report (S. Chambers)

The Foundation met last week. Funding for grant programs for the year was disccussed, which included Saturday Family Fun Hour; Tweens Gaming and Fun Hour; a panel titled Women Run Durham; and Digging Seeds Durham program. A flyer is forthcoming.

Library Fest will be held April 2022. More information detailing authors will be shared at a later time.

Friends of the Library (J. Lerner)

The Friends generated a profit from sales for the second month. They are running a 20% off sale. Friends continue to coordinate a full publicity campaign to present to the board in February. DVD pop-up sale was postponed due to increase in pandemic numbers. The budget for their fiscal year which began on January 1, 2022 was approved. Funding was set aside as a line-item for library funding. The previous year the Friends were unable to budget for library funding.

Library Reports (T. Baggett)

Budget is currently in process, and a meeting will be held with Ms. Chambers and Mr. Kinsley for discussion. There will be an opportunity for funding requests for library.

Safety measures have been changed due to Omicron variant. Meeting room capacity is limited to half the original numbers. Masks are required to be worn entire time room is occupied.

Programs continue to be held virtually until determined it is appropriate to return to in-person programming.

Ms. Baggett shared general location statistics and these are attached to the January 2022 minutes.
